## ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

### SUMMARY

#### Offer Price and net proceeds from the Share Offer

- The final Offer Price has been determined at HK\$0.50 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the final Offer Price of HK\$0.50 per Offer Share and 250,000,000 Shares offered by the Company, the net proceeds from the Share Offer, after deducting the underwriting commissions and other expenses in connection with the Share Offer, are estimated to be approximately HK\$86.8 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

#### Applications under the Public Offer

- The Offer Shares initially offered under the Public Offer have been moderately over-subscribed. A total of 4,939 valid applications were received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS, for a total of 80,830,000 Public Offer Shares, representing approximately 3.23 times of the total number of 25,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- In view of the over-subscription in the Public Offer by less than 15 times and the over-subscription in the Placing, in accordance with Guidance Letter HKEx-GL91-18, the Allocation Cap (as defined below) is applicable. The Sole Bookrunner has applied the reallocation procedures as described in the paragraph headed “Structure and conditions of the Share Offer — Re-allocation of the Offer Shares between Placing and Public Offer” in the Prospectus. A total of 25,000,000 Offer Shares have been reallocated from the Placing to the Public Offer. As a result of such reallocation, the final number of Offer Shares allocated to the Public Offer has been increased to 50,000,000 Offer Shares, representing 20% of the total number of Offer Shares available under the Share Offer, and being allocated to 4,939 successful applicants under the Public Offer. The Sole Sponsor and each of the Directors confirm that the Allocation Cap (as defined below) has not been exceeded.

## Placing

- The Placing Shares initially offered under the Placing have been slightly over-subscribed for approximately 1.03 times of the total number of 225,000,000 Placing Shares initially available for subscription under the Placing. The final number of the Placing Shares allocated to 114 placees is 200,000,000, representing 80% of the total number of the Offer Shares initially available under the Share Offer. A total number of 51 placees have been allotted 10 board lots or less, representing approximately 44.7% of the total number of the 114 placees under the Placing. These placees have been allotted approximately 1.02% of the Offer Shares under the Placing after reallocation to the Public Offer. A total number of 6 placees have been allotted 5 board lots or less, representing approximately 5.3% of the total number of the 114 placees under the Placing.
